EFEE WORK PROGRAMME 2015

EFEE proposes an ambitious Work Programme in order to raise awareness on and increase commitment to the European policy agenda in education, training and youth, to inform the European Commission (EC) on our members' view, to influence EC policy, to exchange information of members, and to network. The Work Programme has been divided into 7 different pillars that are interlinked, in order to embed new activities with existing ones.

Pillar I Participation in DG EAC and DG EMPL WGs

Since 2014, members of EFEE and the EFEE secretariat take part in five ET2020 Thematic Working Groups of DG EAC on VET, Adult Learning, Modernising Higher Education, School Policy, and Transversal Skills. The secretariat coordinates the input to these Working Groups and the outputs of these Working Groups are communicated to all members.

Pillar II Social Dialogue working groups and projects

We planned the following European Sectoral Social Dialogue in Education activities for EFEE members and members of the European Trade Union Committee for Education (ETUCE):

- WG 9 March; theme a.o. Schools of 21st century: supporting a new generation of educators by enhancing the professional profile of teachers, trainers. Dissemination of outcomes of 2014 project on Effective School leadership.

Pillar IV Enhanced partnerships activities

EFEE works closely together with other European organisations in order to strengthen our position at EU level:

- Ensures representation of Education sector at cross-sectoral social partner meetings
- Prepares joint declarations with CEEP ahead of Tripartite Social Summits
- Takes part in the Public Services Employers Forum meetings to link with other sectors
- Promotes link VET with labour market by:
 - Active participation of EFEE VET members in ETUC seminar on "The role of the education sector in improving the quality of apprenticeships" (13 January);
 - Representation of EFEE in seminar of CEEP, BusinessEurope and UEAPME on the cost effectiveness of apprenticeship schemes – making the business case for apprenticeships (16-17 April);
 - Preparing a pledge together with ETUCE for the European Alliance for Apprenticeships, which will be presented during the meeting of Ministers in charge of Vocational Education and Training, European Social Partners and the European Commission in Riga on 22 June.

Pillar V Capacity Building activities:

Strengthening the relations with our members and possible new members is an important priority for 2015. We do this a.o. by organising the following activities:
